[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

During the time frame of April 14, 2014 thru April 17, 2014 Detective [REDACTED] with the Pensacola Police Department was working in an undercover capacity attempting to identify persons using ARES or Bit Torrent peer to peer software on the Internet to traffic and/or distribute images of child pornography. During this time frame Detective [REDACTED] successfully downloaded files which contained child pornography from an individual utilizing the IP address of 174.69.15.106.

On April 16, 2014 the case was forwarded to [REDACTED] with the Department of Homeland Security in Pensacola. On April 16, 2014, [REDACTED] served a subpoena to Cox Communications who maintained/ leased the IP address 174.69.15.106 for the dates of April 14, 2014 thru April 17, 2014.

On May 9, 2014 [REDACTED] Subpoena response specialist with the Subpoena Compliance Office of Cox Communication provided the following information regarding the aforementioned subpoena:

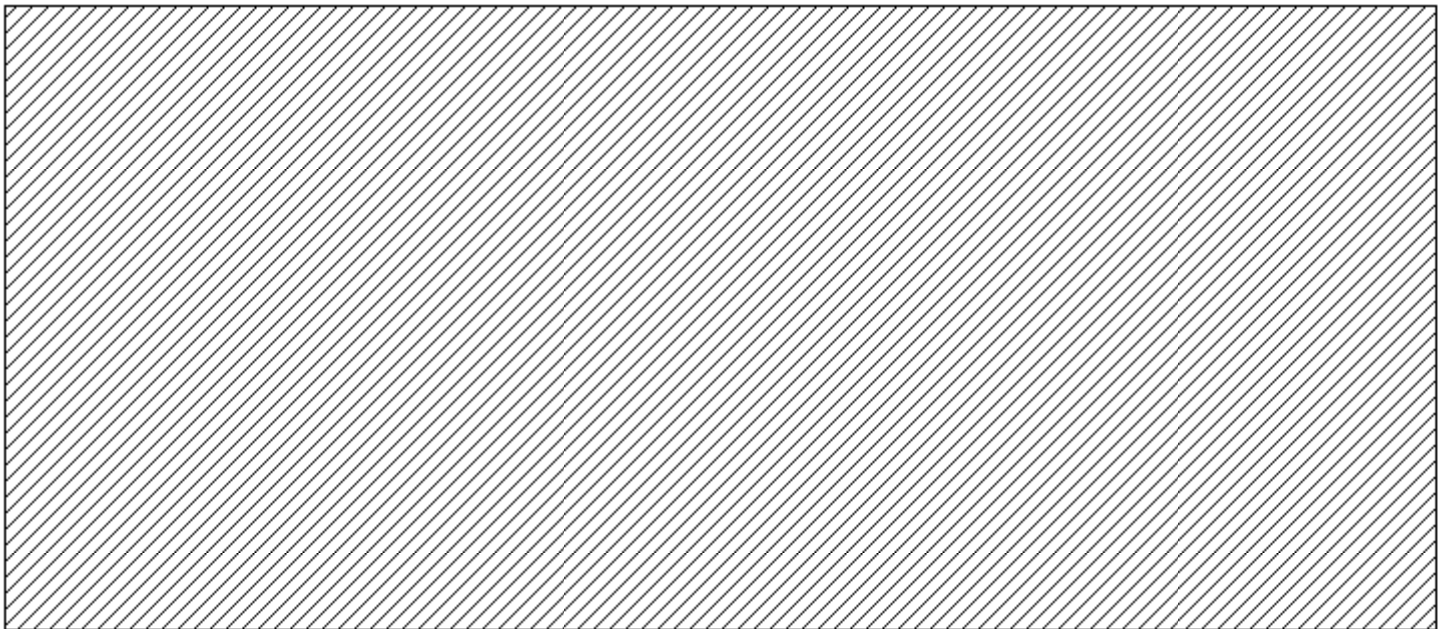
During the execution of the search warrant Jonathan Bryant was interviewed. During Bryant's Post Miranda interview he admitted to using BitTorrent (Peer to Peer) to obtain his pornography. J. Bryant also admitted to using the search term of PTHC to look for his pornography. J. Bryant was asked what PTHC stood for and he admitted he knew PTHC stood for PRE-TEEN HARD CORE. J. Bryant was asked what types of images were obtained when he searched for PTHC. J. Bryant admitted PTHC file could obtain any type of sexual act from pictures of girls posing to full video. J. Bryant also admitted some of those files had children performing sexual acts.

On 8/19/2014 I viewed the all the Digital Forensic Repots from Digital Forensic Examiner (DFE) KC Campbell.

There were 729 videos discovered on the hard drive of the Dell Inspiron 1525 Laptop Computer discovered in Room H. Of those 729 videos, based on my training and knowledge I believe 80 of these videos depict sexual acts being performed by children. The age ranges in these videos vary from toddlers to pre-teens. The children in these videos are engaging in sexual acts including oral, vaginal, anal penetration, bondage and bestiality.
