[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 3-19-14 the Walton County Sheriffs Office VICE/Narcotics Unit served a probable cause search warrant at 193 Seminole Terrace, DeFuniak Springs, Florida. During the execution of the search warrant various items related to trafficking of methamphetamine and cultivation of marijuana were located, to wit; suspected methamphetamine oil, eye droppers containing suspected acid, multiple homemade smoking devices for methamphetamine and marijuana, seventeen suspected marijuana plants, and ammonium nitrate.

During a Post-Miranda recorded interview with Daniel Joseph Smith, Mr. Smith admitted that the plants growing on the front porch were his and they were marijuana plants. He also admitted that the bottles containing bi-layer liquids in the back bedroom were his. When asked what was in them, he said "Meth Oil." There were in fact a total of three bottles containing bi-layer liquids, that were seized as evidence. The total weight of the bi-layer liquids is approximately 552

grams.

During a Post-Miranda recorded interview with Ava Dianne Bryant, she admitted to seeing Daniel shaking a bottle earlier in the night. She explained that she knew his actions, based on previous experience, as making meth. She described the bottle to be a "Coke" bottle with fertilizer and liquid in it. She also admitted that that plants on the front porch were Daniel's.

During a Post-Miranda recorded interview with James Oren Lewis IV, he admitted that the plants on the porch were marijuana plants and they belonged to Daniel.

All items of evidence were seized and taken to the Walton County Sheriffs Office. This occurred in Walton County and violates F.S.S. 893.13, 893.135, and 893.147.
