CHARGES: D01 - Vehicular Homicide								
NARRATIVE:								
Vehicle 1 (V01) was traveling westbound on Olive Road, closely following another vehicle, the driver of								
whom she had an altercation with earlier that evening. The driver of the other vehicle traveled westbound								
into the eastbound lane and braked to avoid V01. Subsequently, the driver of V01 lost control of V01,								
traveled partially into the eastbound lane, over-corrected, traveled back into the westbound lane, and								
over-corrected again. V01 then slide sideways facing south across the eastbound lane of Olive Road, and								
onto the shoulder. The right side of V01 then struck a tree in front of 215 Olive Road. V01 partially rotated								
in a clock-wise manner, and came to final rest facing northbound in the area of collision.								
On 04/28/2013, the passenger, Cassidy Dunaway, was pronounced deceased by Doctor A. Torres at								
Sacred Heart Hospital. Traffic Homicide charges are pending.								
****Update**** On 04/25/2014, the trial for D01 concluded resulting in a guilty conviction for Vehicular								
Homicide for the death of the passenger, Cassidy Dunaway. The sentencing hearing will determine the								
penalty.
