NARRATIVE:
V-1 was traveling northbound in the outside lane of SR 291 (Davis Hwy) from Atwood Dr. The pedestrian was walking eastbound across the northbound lanes of SR 291. The pedestrian walked directly in front of V-1 causing the driver of V-1 to swerve into the center lane in an attempt to avoid striking the pedestrian. The right side of V-1 struck the pedestrian causing the pedestrian to strike the windshield. V-1 came to rest in the center lane of SR 291 north of Atwood Dr. The pedestrian came to rest in the outside lane of SR 291 north of Atwood Dr. The pedestrian was transported to Sacred Heart Hospital and was later pronounced deceased from his injuries.

****UPDATE**** Next of kin notification has been made. The crash occurred on 5-25-14 and the pedestrian expired on 5-26-14.
