Carmichael and codefendant's damaged facility property in excess of \$1000 to include damage to telephones and secured doors.

Carmichael and the codefendant's fled from the scene by breaking the secured facility doors and fleeing the facility. Carmichael and the codefendant's were located and arrested by law enforcement for the above offenses.

Based on my investigation which included interviews with the staff, defendants and the gathering of physical evidence, your Affiant has just and reason able grounds to believe and does believe that the defendant, Carmichael, committed to the offense(s) of participate or causing a Riot in a Detention Facility in violation of F.S.S. §70.01(2); Battery on Detention Staff in violation of F.S.S. 784.075; Criminal mischief over \$1000 in violation of F.S.S. 806.13(1b3); Escaped child from residential commitment facility in violation of F.S.S 985.721.2. [STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Sunday, September 14, 2014 at approximately 2343 hours, Lynda Williams and codefendant's did participate, incite or contribute to a riot. This incident occurred at 1515 Mar Walt Drive, Ft. Walton Beach, Florida. This location is a detention facility contracted by the Department of Juvenile Justice and is known as the Gulf Coast Treatment Center. During the riot the defendant and codefendant's forced their way out of the facility and escaped.

On the above date and time Williams participated in a Riot by opposing the detention staff. Williams and the codefendant's opposed the detention staff by word or act. Lynda Williams and codefendant's encouraged a riot by entering other juveniles rooms in an attempt to excite the juveniles to oppose the staff and organize an escape from the facility. This required intervention of law enforcement to secure the facility, and locate Williams and the codefendant's who were arrested.

Williams has been committed to the Gulf Coast Treatment Center by a court of competent jurisdiction.

During the riot, Williams assisted in depriving the staff of communications as a codefendant entered a office and pulled a phone and cable out of the wall and then from a facility nurse as she attempted to make a phone call for help. They battered and opposed medical staff by threats verbal and physical. Williams and codefendant's battered Detention staff by pulling a 72 year old registered nurse's hands off of a telephone and by pushing her into an office. Williams and codefendant's damaged facility property in excess of \$1000 to include damage to telephones and secured doors.

Williams and the codefendant's fled from the scene by breaking the secured facility's doors and fleeing the facility. Williams and the codefendant's were located and arrested by law enforcement for the above offenses. While lawfully detained, Williams provided D/S Jonathan Schlager with a false name of "Monica". Williams refused to identify herself and was only positively identified after a staff member identified Williams.

Based on my investigation which included interviews with the staff, defendants and the gathering of physical evidence, your Affiant has just and reason able grounds to believe and does believe that the defendant, Lynda Williams, committed to the offense(s) of participate or causing a Riot in a Detention Facility in violation of F.S.S. 870.01(2); Battery on Detention Staff in violation of F.S.S. 784.075; Criminal mischief over \$1000 in violation of F.S.S. 806.13(1b3); Escape from residential commitment facility in violation of F.S.S 985.721.2. The above incident occurred in Okaloosa County, Florida where your Affiant is a sworn law enforcement officer. Contrary to the law and against the peace and dignity of the State of Florida.
