NARCOTICS SEARCH WARRANT NETS CASH AND DRUGS

Two Fort Walton Beach men have been arrested as the result of a narcotics search warrant executed today by the Okaloosa County Sheriff's Office Narcotics Unit.

26-year old Dillan J. Touchton of 147 SE Brooks Street is charged with Possession with Intent to Distribute Marijuana and Possession of Drug Paraphernalia. 33-year old Kenton of the same address is charged with Possession of Drug Paraphernalia. During the search, OCSO investigators located approximately two pounds of marijuana, a large amount of cash, a vacuum sealer, marijuana smoke devices (bongs) and other drug paraphernalia.
