## OCSO CHARGES CRESTVIEW WOMAN WITH ATTEMPTED MURDER



The Okaloosa County Sheriff's Office today charged a Crestview woman in connection with a knife attack on her husband.

30-year old Nicole Cheri Parker of 1641 James Lee Boulevard was taken into custody this morning following an overnight search by the OCSO.

Witnesses at a home at 1322 Charlie Day Road in Baker say Parker cut her husband, 35-year old Jerald Wade Parker, across the throat and under the arm while he was engaged in a fight with her ex-husband, 28-year old Donald Wayne Jespersen, shortly before midnight Wednesday.

Investigators say Parker ran from the scene into nearby woods. An OCSO K9 Unit located Parker's purse, some clothes and a knife in the area.

Nicole Parker was located this morning and taken into custody for questioning. Jerald Wade Parker, who had been flown to Sacred Heart Hospital in Pensacola last night, was last listed in critical condition.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On May 6, 2015 the defendant, Nicole Cheri Parker did commit the criminal offense of Attempted Felony Murder.

On the above mentioned date the defendant and the victim, Jerald Wade Parker, who is also her husband, became involved in a verbal altercation while traveling on the roadways throughout Holt, Florida. Also in the vehicle was the defendant's ex-husband, Donald Jespersen. During the altercation the victim exited the vehicle to urinate and Jespersen and the defendant pulled away leaving the victim on the side of the roadway. After walking back to the residence located at 1322 Charlie Day Road, Baker, Florida the victim and Jespersen became engaged in a physical altercation on the back deck of the residence. During the altercation the defendant walked behind the victim as he was being held by Jespersen, pulled his head back with her left hand, reached around the front of his neck with her right hand and cut his neck with the blade of a black and silver folding knife. The defendant then immediately cut the victim again on his left side underneath his arm.

The victim fell to the ground and immediately began bleeding profusely from his laceration that ran from behind his left ear to his Adams Apple and also had heavy bleeding from the laceration under his left arm. The defendant fled the scene and failed to render any aide to the victim.

It should be noted that prior to being transported from the scene, the victim stopped breathing and had to be resuscitated by family members.
