OCSO ARRESTS MARY ESTHER MAN FOR WALMART PHARMACY ROBBERY



The Okaloosa County Sheriff's Office has arrested a Mary Esther man in connection with a robbery that occurred this morning at the Walmart Pharmacy located at 15017 Emerald Coast Parkway in Destin.

31-year old Joshua Brian Boone of Casa Loma Drive was arrested shortly after he robbed the Walmart Pharmacy in Destin at 10:30 a.m. Boone waited for customers to leave the pharmacy area and then gave the clerk a handwritten note demanding "Oxy". He did not show a weapon but put his hand in his jacket implying he had a weapon and threatened the clerk. He then fled the store with the Oxycodone and left in a silver vehicle, described as a Kia Soul.

At 2:30 p.m. an investigator spotted a silver Kia Soul in the rear parking lot of Panini Pete's at 1071 E. US Hwy 98 and observed items in the car that were similar to the ones used during the robbery. They made contact with Boone in the kitchen where he was working and he attempted to flee out a back door but was quickly apprehended. Investigators found several Oxycodone pills and other drug paraphernalia in his shirt pocket at the time of his arrest.

Witnesses at Walmart positively identified Boone as the man who committed the robbery a few hours earlier.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 1, 2016 Joshua Brian Boone the defendant did commit the offenses of Robbery no weapon identified at this time in violation of F.S.S 812.13 (2c), Possession of controlled substance without a prescription in violation of F.S.S. 893.13 (6a) and possession of drug paraphernalia in violation of F.S.S 893.147 (1). These violation occurred within Okaloosa County where I am a sworn Law enforcement officer.

On May 1, 2016 the defendant entered the Walmart Supercenter located at 15017 Emerald Coast Parkway, Destin FL 32541. The defendant approached the Pharmacy counter where he handed the attendant a hand written note requesting

drugs specifically "Oxy" Oxycodone. Specifically the attendant stated the defendant threatened her by stating he would shoot her and that he had a gun. During the demands the defendant had his hand in his jacket pocket protruding towards the attendant as if he had a weapon concealed within. The attendant stated she feared for her life and she notified the on duty pharmacists who then approached the defendant and provided 60 Oxycodone tablets in a prescription bottle. The defendant then departed the pharmacy section exiting Walmart. The defendant was observed entering a Silver/Gray Kia four door vehicle which was described by another employee. During the investigation surveillance footage was obtained from Walmart which gave a clear description of the defendant and the vehicle he was seen arriving and departing the crime scene. Video surveillance also depicted the defendants movements within the store.

A short time later the defendants vehicle was located in the rear parking lot of Panini Pete's restaurant located a short distance from the crime scene. Within the vehicle in plain view were items used during the commission of the robbery. A check of the co-owner the defendant revealed strong resemblance to the robbery suspect. When law enforcement attempted to make contact the defendant who was working in the kitchen of the restaurant, attempted to flee out the back door, where he was taken into custody. Upon his arrest the defendant was in possession of drug paraphernalia specifically a syringe and Oxycodone pills identified as the same brand, color and milligram which were given to the defendant by the pharmacist during the robbery. The defendant could not provide a prescription for the Oxycodone pills at the time of his arrest.

Based upon the circumstances above I have reason to believe and do believe the defendant Joshua Brian Boone did commit the offenses described above.
