FWB TEEN USES BASEBALL BAT TO FEND OFF ATTACK ON HIS MOTHER

A Fort Walton Beach teen used a baseball bat to rescue his mother from a man she says entered her bedroom and sexually assaulted her early this morning.

The Okaloosa County Sheriff's Office today charged 24-year old Xavier Jamar Boyers of 23 Maples Street with burglary with assault or battery and sexual battery on a person physically incapacitated.

The female victim says she sleeping and woke up at her home on Colton Way around 4 a.m. to a man in her bed saying things in her ear and sexually assaulting her. She began screaming and her son came into the room with a baseball bat. The juvenile began striking the suspect with the bat and yelling for him to get out.

The man fled the house but was spotted by a neighbor who had heard the disturbance. OCSO investigators developed Boyers as a suspect. The victim later picked him out of a photographic line-up as her attacker.

Boyers claims the woman had invited him over but investigators say he had no evidence to back up his claim.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Your affiant believes the defendant (Xavier Boyers) committed Burglary and Sexual Battery; to wit, on May 31, 2016, the Okaloosa County Sheriff's Office responded to a Burglary and Sexual Battery located at [REDACTED] Colton Way, Fort Walton Beach, Florida. Investigation revealed the victim and her juvenile son were alone and asleep at their residence. The defendant entered the residence through the back door, went into the victim's bedroom and digitally penetrated her (his finger in her vagina) against her will while she was asleep. The defendant was forced from the residence by the victim and her son and fled on foot; which was observed by an independent witness.

Another neighbor provided your affiant with the defendant's identity.

Your affiant administered a photograph array line-up with during which the victim positively identified the defendant.

Your affiant conducted an investigative follow-up with the defendant who, post Miranda, informed me he "knew why I was there" and it was about what occurred at Colton Way. The defendant fully admitted to entering the victim's residence, lying next to her in her bed, and digitally penetrating her. However, he claimed she invited him over earlier that same evening and informed him the back door would be unlocked. Although the defendant had no telephonic or digital evidence or independent witnesses to support his claims of a consensual and planned rendezvous with the victim. The defendant swore to his oral statements.

Based upon the investigation and evidence presented, your affiant has reason to believe, and does believe, the defendant (Xavier Boyers) committed Burglary, contrary to Florida Statute 810.02(2)(a) and Sexual Battery, contrary to Florida Statute 794.011(5)(b). These offenses occurred in Okaloosa County, Florida, where your affiant is a sworn, law enforcement officer.
