## **FWB MAN FACING MULTIPLE CHARGES AFTER SHOOTING AT VEHICLE**



A 23-year old Fort Walton Beach man faces multiple charges after firing shots at an occupied vehicle around 9:00 p.m. Monday night (05/02/2016).

The Okaloosa County Sheriff's Office has charged Ja'Darious Deunte Brown of 700 Terrence Court with aggravated assault with a deadly weapon without intent to kill, firing missile into occupied dwelling and possession of weapon or ammo by a convicted felon.

One of the victims says he and Brown had an altercation at Heather Glenn Apartments on Hunt Club Street prior to the shooting and Brown threatened him with a baseball bat. About an hour later, the victim and two other witnesses were driving in the area of Gap Creek Drive in Fort Walton Beach when they saw Brown's vehicle, a white Charger, following them. They drove to a fast food restaurant where they say Brown blocked their vehicle in a parking spot with his vehicle. The victim says he attempted to get out of the vehicle and Brown pointed a gun at him and another passenger. The victims were able to get out of the parking lot and attempted to lose Brown in the Lovejoy area. Brown followed, pulled up beside the victims' vehicle and fired three shots. None of the occupants of the vehicle were injured.

Members of the Okaloosa County Sheriff's Office Fugitive Warrants Unit arrested Brown without incident following a traffic stop on Mayflower Court yesterday around 1:00 p.m. Brown also had a Florida Department of Corrections outstanding warrant for violation of probation on the original charges of possession of cocaine, possession of drug paraphernalia and battery.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On May 2, 2016 I responded to 521 Mary Esther Blvd. in reference to a Shots Fired complaint.

The victim stated he was in an altercation earlier in the evening with the defendant, Ja'Darious Deunte Brown. The victim stated Brown was the [redacted] and knew Brown personally. The victim stated Brown exited a white 2016 Dodge Charger with a Mississippi tag and threatened him with a metal bat. The victim stated Brown left but returned a short time later and stated "he's about that life" and then drove off.

The victim stated approximately one hour later he was driving with the witnesses in the area of Gap Creek Dr. The victim stated he observed Brown driving the same white Charger in the area. The victim stated Brown started following him and yelling at him through his vehicle window. The victim stated Brown followed him to Taco Bell and blocked the victim's vehicle in a parking space. The victim stated he attempted to get out of the vehicle and Brown pointed a handgun at him and one of the witnesses. The victim stated he departed the area and Brown followed them to the area of Love Joy Rd. and Shirley Dr. The victim stated Brown pulled the white Dodge Charger beside the driver's side of the victim's vehicle and fired three shots at him through the Chargers passenger window. The victim stated one of the rounds hit the front drivers side tire, popping it and another round struck the bottom of the driver's door. The victim stated he was in fear for his life when Brown fired the weapon at the vehicle. The victim completed an affidavit of complaint which I swore him to.

I observed the front driver's side tire was flat and damage to the lower driver's door which was consistent with a bullet striking the door from an angle.

Sworn written statements by both witnesses were consistent with the victims statements and also positively identified Brown as the suspect.

On 2/13/14 in Okaloosa County, Florida Brown was convicted guilty of Possession of Cocaine which is a 3rd degree Felony.

Based on my investigation which consisted of interviews with the victim, the witnesses and my observations of physical evidence. I have probable cause to believe and do believe the defendant, Ja'Darious Deunte Brown violated F.S.S. 790.19 Firing Missile Into Occupied Dwelling/ Vehicle, F.S.S. 784.021(1)(a) Aggravated Assault w/ Deadly Weapon w/o Intent to Kill and F.S.S. 790.23(1)(a) Possession of Weapon or Ammo By a Convicted Felon. This incident occurred in Okaloosa County, Florida.
