DEPUTIES ARREST DESTIN BURGLAR



A Fort Walton Beach man who burglarized a Destin home two days ago was tracked down by Okaloosa County Sheriff's Office deputies after he turned on one of two stolen Apple MacBook computers. 24-year old Joseph Michael Kriech of 206 Hawthorne Circle in Fort Walton Beach is charged with grand theft of more than \$10,000, burglary, and dealing in stolen property.

Kriech is accused of breaking into a home on Belacourt Drive in Destin May 7th and stealing a flat screen television, two MacBook computers, a five thousand dollar purse, and two sets of golf clubs. The stolen property totaled nearly \$13,000. Kriech used the victim's stolen credit cards at Tom Thumb stores, Red Box video machines, Walmart and other locations. He also says he sold the tv and one of the computers for money and marijuana.

The victim reported that her MacBook had been turned on and deputies tracked it yesterday to Kriech's home at 206 Hawthorne Circle. Deputies have recovered most of the stolen merchandise.



[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 05/07/2014 the Defendant Joseph Kriech did commit the offenses of Burglary to an occupied dwelling, Grand Larceny, Dealing in stolen property, and Fraudulent use of a credit card.

On 05/07/2014 the Defendant willingly and unlawfully entered the occupied dwelling located at 4145 Belcourt Dr in Destin, FL. While inside this dwelling, the Defendant proceeded to steal a flat screen television (\$1,000), two (2) Apple Mac book computers (\$1,900), a Louie Vitton Couture purse (\$5,000), and two (2) sets of golf clubs totalling (\$5,000). The entire value of stolen property in this case exceeds \$12,900.

The Defendant proceeded to use one of the Victim's credit cards, more than two times, to charge an unknown total dollar amount at Tom Thumb stores, multiple Red Box video machines, Walmart and other point of sale locations throughout Okaloosa County, FL. Additionally, the Defendant advised that he proceeded to the Palms of Destin resort where he met with an individual known only as "D". Defendant Kriech sold the flat screen television and one (1) of the Mac Book computers to him for \$350.00 and an unknown amount of marijuana.

After subsequent contact with the Victim, she advised that her Mac Book had been powered on and was tracking to the specific address of 206 Hawthorne Circle in Fort Walton Beach, FL. District Deputies were notified and responded to this location where contact was made with the Defendant. A post Miranda confession was obtained from the Defendant who stated that he parked his vehicle in a secluded area near the entrance to the subdivision. He then advised that he continued to the back yard of this residence where he watched and waited for all occupants to either leave the residence or go to bed. Defendant Kriech stated that he then entered the residence through the back door and proceeded to steal the flat screen television, the two (2) Mac Book computers, the Louie Vitton purse and the two (2) sets of golf clubs from the back yard area of this residence. The Defendant advised that he completed these acts in three trips inside of the residence. As stated above, he then confessed to selling the stolen property in exchange for money and marijuana. Upon confessing to these crimes, the Defendant provided one (1) Mac Book computer, one (1) Louie Vitton purse, and two (2) sets of golf clubs which were in the Defendants residence at the time of confession.

These offenses are evidenced by multiple sworn Affidavits of Complaint, coupled with the Defendant's post Miranda verbal admission that he did knowingly and unlawfully enter this occupied dwelling, remove the Victim's personal belongings from within, and dealt in known stolen property by selling a portion of the Victim's property.

Based on my investigation, I have reason to believe and do believe the defendant, Joseph Michael Kriech, did commit the violations of F.S.S. 810.02(3); Burglary to an occupied dwelling, 812.014 (2c3); Grand Larceny, 812.019(1); Dealing in stolen property; and 817.61 Fraud-illegal use of a credit card- more than twice in 6 months. These offenses occurred in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.
