NARRATIVE:
 Vehicle-1 (V01) was weaving in and out of traffic at a high rate of speed westbound on US Highway 90. Vehicle-2 (V02) was traveling westbound in the inside lane on US Highway 90 approaching the intersection of Antioch Road. As V01 was approaching slower moving traffic along with V02 in the inside lane. V01 went to pass V02 in the outside lane, V01 drove onto the paved shoulder of the roadway. V01 started to wobble, causing Driver-1 to be ejected from V01, at which point D01 came into contact with V02. V01 came to final rest in the outside lane facing a easterly direction. Driver-1 came to final rest in the outside lane facing a northerly direction. V02 drove out of the area of collision and came to rest on the north shoulder of US Highway 90 just west of Antioch Road.
