CHARGES: DUI Manslaughter, Dui with property damage/personal injury, failure to wear seatbelt, driving on wrong side of divided highway

NARRATIVE:
On July 7, 2014, Vehicle 1 was traveling eastbound on U.S. 98 when it crossed a raised concrete median, and entered the westbound lanes. Subsequently, the front left of Vehicle 1 struck the front left of westbound Vehicle 2. The driver of Vehicle 2, Gregory Winter, died on August 16, 2014 as a result of injuries sustained in this crash. Medina's blood alcohol level was 0.146. He was placed under arrest by the Florida Highway Patrol on October 21, 2014 and is being held without bond at the Santa Rosa County Jail.
