CHARGES: Pending Blood Results

NARRATIVE:
 Vehicle01 was traveling southbound in the outside traffic lane of State Road 291 (Davis HWY). According to witnesses, Vehicle01 was traveling at a very high rate of speed. Vehicle01 attempted to complete a right turn into the northern entrance/exit driveway of Village Oaks Mall, located at 6251 N Davis Hwy, Pensacola, FL 32504. During the course of the right turn, the front right tire of Vehicle01 mounted the northern curb of the entrance/exit driveway. Driver01 attempted to bring Vehicle01 onto the travel lane, Driver01 over corrected, causing Vehicle01 to travel in a southeasterly direction across both the southbound and northbound lanes of traffic for State Road 291 (Davis HWY). Vehicle01 continued to travel in a southeasterly direction, until the front tires collided with the northbound curb of State Road 291 (Davis HWY). This collision, caused Vehicle01 to overturn four (4) times while continuing to travel in a southeasterly direction. Vehicle01 came to final rest one hundred and four (104) feet from the northbound curve of State Road 291 (Davis HWY) and was located overturned in the parking lot of Hank's Fine Furniture, located at 6320 N Davis Highway.
