**NARRATIVE:**  
 On Friday night July 11, 2014 at approximately 9:30 PM Roy Reasonover was attempting to cross Mobile Highway South of Edison Drive. An unknown vehicle struck Mr. Reasonover in the northbound right turn lane for Edison Drive. Mr. Reasonover was dragged under the vehicle for twenty one feet. The vehicle then fled the scene of the crash leaving Mr. Reasonover lying in the road. Investigators have reason to believe the vehicle was a sport utility vehicle of some type and may have traveled east on Edison Drive while fleeing the scene. The vehicle should have front end damage consistent with a pedestrian collision.
