[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

The Defendant, Lonnie Dion Peterson, did commit the criminal act of False Threat to Plant a Bomb or Weapon of Mass Destruction according to Florida Statute 790.163 by writing a letter indicating there would be a bomb going off at a location in DeFuniak.

The letter further stated the "location is where everybody gets Justice handed down Justice will be handed down today this bomb is going to go off Between the hours of 7:00 a.m and 3: pm Monday May 12, 2014 this bomb ant intended to hurt the Innocent just the Guilty."

The complainant stated he received phone calls from an unknown number and he engaged in an argument with the person. At some point during the conversation, the person said he should check his mailbox. The complainant's son checked the mailbox and located the letter.

The complainant initiated a phone trace on the numbers and I contacted Century Link with an exigent circumstances request. I was advised because the complainant had initiated the call trace and due to the circumstances she could provide me with the numbers. The Century Link clerk advised me there were three traces with one of the numbers being 850-892-8111 and two of the traces being the number 850-399-1993.

A search of Walton County Sheriff's Office databases indicated the number 850-399-1993 was listed for Sandra Rogers and Lonnie Peterson. A search of Walton County Clerk of Courts indicated the Defendant was scheduled for an appearance in Court on May 12, 2014.

Ms. Rogers stated during an interview she had walked with her son, the Defendant, up the road to where the complainant lived. She was asked if she observed the Defendant put anything in the mail box and she said no, but he did tell her to turn around and walk home.

The Defendant provided consent to search his bedroom. During a search of his bedroom, a black flashlight was located that corroborated the statement of Ms. Rogers. She stated the Defendant carried that flashlight as well as a kitchen knife when they walked. During this search, a piece of paper was also located with the phone number of the complainant. Both of these items are evidence in this case.

During a post-Miranda interview, the Defendant stated he did write the letter. He stated he wrote the letter because he was under a lot of stress.

This incident did occur in Walton County, Florida.
