#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On Friday 7/11/2014, I responded to Walmart in reference to a Domestic Altercation which had already occurred between Robbie Skaggs and Teresa Greene. While in Walmart, Teresa was able to separate herself from Robbie by going to the bathroom. At this time she alerted someone to call 911. When I made contact with Teresa I noticed she was physically and emotionally distraught, and I observed she had obtained several injuries from the incident including a swollen black eye.

Teresa stated the incident began Wednesday 7/9/2014, around mid-afternoon. At this time Robbie attacked her inside her residence. He hit her in the back of the head with the blunt end of a hatchet causing several bruises and lacerations on the back of her head. Robbie also used a machete during the attack which caused small lacerations and bruising around Teresa's rib cage. She also received other bruising which resulted from being kicked and punched by Robbie. After the attack she was held inside her bedroom until Thursday afternoon, and was unable to leave her residence or use a phone due to his constant supervision. From Thursday afternoon until the trip to Walmart on Friday evening, Teresa said he continued to supervise her, not leaving her side or allowing her to leave the residence.
