[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 03/12/14 between 2300 and 2400 hour's six (6) vehicles, located at the Walton County Jail parking lot, 796 Triple G Road, Defuniak Springs, Fl. The vehicles sustained damage totaling approximately \$1611.00. Damages ranged from sliced tires, a broken windshield to body damage. The following is a list of vehicles and the damages incurred:

2011 Chevrolet Caprice Patrol Cruiser; right rear passenger tire sliced with a damage value of approximately \$150.00.

2010 Pontiac G6; front passenger side tire sliced with a damage value of approximately \$100.00.

2010 Nissan Altima; front and rear passenger side tires were sliced with a damage value of approximately \$170.00.

2000 Ford Truck; front and rear driver's side tires were sliced with a damage value of approximately \$212.00.

2005 Chevrolet 1500 Truck; front and rear driver's side tires were sliced along with a broken front windshield and broken driver's side view mirror. The approximate damage value was \$920.00.

2008 Buick Lucerne; sliced tire with a damage value of approximately \$125.00.

The aforementioned property was damaged during one course of conduct.

On 04/13/14 after reviewing surveillance footage, arrest records and interviewing corrections officers working during the time of the incident from the Walton County Jail, Phillip D. Tidwell II was identified as being the suspect in the surveillance footage. Tidwell was observed retrieving what appeared to be a golf club from the trunk of his car, which

was parked beside the marked patrol car. Tidwell is observed swinging the "golf club" around the patrol car, disappears out of the frame of the video, walking toward the area where the other vehicles were parked that were damaged. Tidwell is then observed retrieving an unknown item from within the driver side of his vehicle, walking to the rear passenger side of the patrol car (which was backed into the parking spot) squatting by the rear tire and then returning to his vehicle. Tidwell is observed entering and exiting the jail lobby numerous times. Shortly after Tidwell is seen squatting by the patrol car, Tidwell walks into the jail lobby for a brief moment, then returns to his vehicle. Tidwell moves his vehicle and parks in another location out of the view of the surveillance camera. Tidwell is then observed returning to the jail lobby.

During review of the surveillance footage, Tidwell is the only individual observed at the patrol car and walking toward the area of the parking lot where the other damaged vehicles were parked. All vehicle tires sustained the same type of damage.

On 03/17/14 Sergeant Dozier was contacted by Tidwell's attorney's office. They advised that they were representing Tidwell and needed to find out what the total cost was involving the vehicles he had damaged. They advised that he stated he was intoxicated and scared when he found out that law enforcement was looking for him. Tidwell wanted to know the total damage cost of the damages he caused so he could turn himself in and resolve the issue.

This incident did occur in Walton County FL and is in violation of FSS 806.13 1(b)3.
