[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 22 March, 2014, Jack Donald Adair, III, did commit the offense of Dealing in Stolen Property, per Florida State Statute 812.019(1), when he did sell a stolen Browning twelve gauge shotgun, serial number 3M19732, to Daniel Copeland, the owner of Copeland's Gun and Tackle, 17290 South US Highway 331, Freeport, Florida 32439.

The shotgun, a Belgian manufactured Browning, was stolen from Clayton Adkinson, 1608 Corbin Gainey Road, Defuniak Springs, Florida 32435, on 21 March, 2014.

The shotgun was sold by Adair for three hundred and fifty dollars (\$350.00). Adair should have reasonably known that the shotgun was stolen as the gun was worth over one thousand dollars (\$1000.00) per online gun dealer sites. Copeland did confirm per a sworn Voluntary Statement that he did buy the shotgun from Adair for three hundred and fifty dollars (\$350.00).

This did occur in Walton County, Florida.
