[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On March 21, 2015 Deputies with the Walton County Sheriff's served an active warrant on William Mitchell Golden at his residence located at 1892 Flowersview BLVD, Laurel Hill, FL. 32567. Upon the arrest of golden deputies witnessed Golden throw a black container down containing methamphetamine. Deputies also removed several pieces of aluminum foil off of Golden that contained burnt methamphetamine residue. Investigators with the Walton county Sheriff's Office responded to the scene and received consent to search on the property. During the course of the search Investigators

discovered over fourteen grams of methamphetamine oil, located in a twenty ounce water bottle, two used twenty ounce cook vessels, and a box of instant cold packs that contain ammonium nitrate, which is used in the process of manufacturing methamphetamine. Investigators also discovered stripped lithium batteries that are used in the manufacturing of methamphetamine. Investigators also discovered a blue tablet scored with (Cor 132) on one side of the tablet. These markings identified the tablet as Adderall, a schedule II narcotic. This is in violation of Florida state statues 893.13.1a1, 893.13.6a, 893.135.1f1 and 893.147.1. Theses offenses did occur in Walton County, FL.
