## ADDENDUM OF PROBABLE CAUSE

I have just and reasonable grounds to believe, and do believe the above named defendant did commit the offense of Battery -Touch or Strike (DOMV) in violation of Florida Statute 784.03 (1a1). On 01/20/2016, at approximately 1651 HRS, the victim and his live in girlfriend, who is the mother of his child, got into a verbal argument over the defendant turning the volume up on the surround sound attached to his TV. When the victim attempted to get the remote to turn the volume down the defendant grabbed the victim's penis. After the defendant grabbed the victim's penis, the victim pushed the defendant in an attempt to get her to release his penis. After the victim pushed the defendant the defendant retaliated with several strikes, unspecified if it was closed or open handed, to both sides of the face.

This offense is evidenced by a sworn verbal statement, provided by the victim, who refused to complete an Affidavit of Complaint. The victim stated the defendant and him engaged in a verbal argument when the defendant then turned volume up on the TV surround sound system in an attempt to drown out the victim talking to her. The victim stated he attempted to get the remote and turn the surround sound down, due to their 9 month old daughter being in the room. The victim stated when he reached for the remote the defendant grabbed his penis. The victim stated at that point he pushed the defendant to relase the grip on his penis. The victim stated the defendant then struck him on both sides of the face multiple times.

During the course of the investigation, the defendant stated in a sworn verbal statement that she and the victim were engaged in a verbal argument when she grabbed the victim's penis as he was attempting to reach for the remote. The defendant also stated the victim pushed her and she then punched him in the face.

I observed red marks on both sides of the victims face which was photographed, copied to a disc and placed into evidence along with body camera footage from my department issued Wolfcom Body Camera.

This offense did occur within the city limits of Crestview, Okaloosa County, Florida where I am a sworn Law Enforcement Officer.
