INCIDENT SUMMARY

On 02-16-2016 at approximately 1411 hours Sergeant Lewis and I were driving in the area of West Edney Avenue. I observed Archillius Mendrell Perry in the drive way of 407 West Edney Avenue. It was known to us that Perry was a wanted person out of the Okaloosa County Sheriff's Office (OCSO) for felony Violation of Probation.

Sergeant Lewis and I turned around and approached the residence in Sergeant Lewis' unmarked patrol vehicle. As we approached the residence Perry walked to the rear of the residence then began running east behind the residence. Sergeant Lewis and I followed Perry but as we rounded to the east rear corner of the residence we lost sight of Perry. A citizen informed me Perry ran into a wooded area north of our location at the intersection of Bay Street and South Savage Street.

A perimeter was established and K9 Officer Kriser and K9 Officer Mullinnix arrived on scene to conduct a track. K9 Officer Kriser and his K9 partner Kody began to track from South Booker Street. A short time later Corporal McCallum advised Perry was running back towards to Bay Street and South Savage Street.

I observed Perry running towards me. Due to Perry being known to be violent and being in possession of firearms I un-holstered my department issued Glock model 21SF and maintained a low-ready in the direction of Perry. I gave Perry loud verbal commands to Perry to get on the ground to which he complied. K9 Officer Mullinnix and his K9 partner Sonic entered the wooded area in front of me. K9 Officer Mullinnix and his K9 partner Sonic provided cover while I detained Perry in handcuffs.

I effected an arrest on Perry for Resisting Officer Without Violence and performed a Search Incident to Arrest. During the search I discovered a clear plastic bag containing a green leafy substance in Perry's front left pants pocket. Based upon my training and experience I suspected the green leafy substance to be Marijuana. I assisted Perry to his feet and escorted him out of the woods. I transferred custody of Perry to Officer Tingle to be transported to the Okaloosa County Department of Corrections.

I performed a field test on the suspected Marijuana which presented a presumptive positive for the presence of Marijuana.

On 02-16-2016 the above named Defendant did commit the offenses of Resisting Officer Without Violence pursuant to Florida State Statute 843.02 and Possession of Marijuana - Under twenty (20) grams pursuant to Florida State Statute 893.13(6)(B).

At approximately 1411 hours Sergeant Lewis and I observed the Defendant at 407 West Edney Avenue. The Defendant was known to us to be a wanted person out of the Okaloosa County Sheriff's Office for Felony Violation of Probation. As Sergeant Lewis and I approached the drive way of 407 West Edney Avenue in Sergeant Lewis' unmarked patrol vehicle the Defendant approached the rear of the residence where he began to run towards the east. Sergeant Lewis and I gave chase to the Defendant.

The Defendant fled into a wooded area at the intersection of South Savage Street and Bay Street. A perimeter was established and K9 Officer Kriser and his K9 partner Kody began to track the Defendant through the wooded area. The Defendant observed K9 Officer Kriser and Corporal McCallum then fled on foot to the east and jumped fences to flee from law enforcement.

I observed the Defendant running towards my direction. I gave the Defendant loud verbal commands to get on the ground. The Defendant complied and was taken into custody.

During a Search Incident to Arrest I located a plastic bag containing a green leafy substance in the Defendant's front left pants pocket. Based upon my training and experience I suspected the green leafy substance to be Marijuana. I performed a field test on the suspected Marijuana which presented a presumptive positive for the presence of Marijuana.

These offenses did occur within the city limits of Crestview, Okaloosa County, Florida.
