INCIDENT SUMMARY

On January 15, 2016, at approximately 2109 hours I was dispatched to Wal-Mart Supercenter, located at 3351 Ferdon-S Blvd., in reference to a retail theft. The call notes advised to make contact with Bradley of Wal-Mart asset protection. The call notes also advised the suspects were driving a blue or black Escalade with a black plastic garbage bag over the rear window headed towards Brookmeade Dr. Upon arrival I attempted to locate the vehicle, however, I was unable to locate the vehicle.

After I canvassed the area for the suspect's vehicle, I made contact with Bradley Richardson, who stated on 02/15/2016, at approximately 2030 hours, he observed a female, he identified as Lana Herbert from previous experiences, in the men's clothing department. Bradley stated he observed Lana select a white men's dress shirt along with other items from the same area. Bradley stated Lana walked through several areas of Wal-Mart, before heading to the "greeting card section." Bradley stated Lana met another female, later identified as Tiffany Todd, and placed her items in Tiffany's cart. Bradley stated while near the greeting cards he observed Tiffany select a few greeting cards and place them into her purse. Bradley stated shortly after he observed Lana place the white men's dress shirt under her jacket. Bradley stated he observed Tiffany and Lana walk through several other sections and conceal items, however, he was unable to advise as to those items. Bradley stated Lana and Tiffany then proceeded to the cash registers and paid for the items in their cart, however, they failed to pay for the concealed items before heading towards the exit passing all points of sale without paying for the concealed items. Bradley stated he attempted to stop Lana and Tiffany in reference to this incident by identifying himself as being with Wal-Mart asset protection and displaying his name badge. Bradley stated Lana and Tiffany failed to comply with instructions before leaving the scene. Bradley stated he also had a court ordered document that stated Lana was not allowed to be at Wal-Mart. While Bradley produced the document and completed a sworn Affidavit of Complaint, Ofc. Mullinnix was able to locate the vehicle that fled the scene and initiated a stop on the vehicle. See Ofc. Mullinnix's supplemental report for further information.

While Ofc. Mullinnix was with the stopped vehicle, I advised Bradley we would need for him to do a showup. Bradley stated he would. I then relocated along with Bradley to the intersection of Crossland St. and Brock-E Ave. I asked Bradley if he recognized anyone, to which he replied the two females, Lana Herbert and Tiffany Todd, where the females he observed conceal the items and not pay for them. Bradley and I then relocated to Wal-Mart for him to finish completing his sworn Affidavit of Complaint. While at Wal-Mart, Ofc. Mullinnix advised he had other merchandise he believed may be stolen from Wal-Mart. Bradley and I then relocated back to Crossland St. and Brock-E Ave. Bradley advised he only observed them take the cards and the white men's dress shirt. He knew they were in the section of the other items, but stated he did not observe them take those items, and he did not have video surveillance of the items. Bradley and I then relocated back to Wal-Mart where he completed the Sworn Affidavit of Complaint.

After collecting the sworn Affidavit of Complaint from Bradley along with a copy of the court order Wal-Mart had on file for Lana, I returned to Brock-E Ave. Lana and Tiffany were placed in mechanical restraints and were advised they were under arrest. Ofc. London was notified to be en route to search the Lana and Tiffany. See Ofc. London's supplemental report for further information.

After being searched Tiffany was transported to the Okaloosa County Jail by Ofc. Baier. See Ofc. Baier's supplemental report for further information.

After being searched Lana was placed in the rear of my patrol vehicle and transported to the Okaloosa County Jail.

After Lana and Tiffany were released into the custody of the Okaloosa County Jail, it was discovered Lana had concealed

a plastic bag containing a 8 white pills, later identified as Tylenol 3 with codeine, in her brassiere. It was also discovered Tiffany had concealed a prescription pill bottle, containing oxycodone and 2 unknown white pills, in her vagina.

The vehicle Lana and Tiffany were travelling in, a 2000 black Cadillac displaying the license plate J111PP was towed from the scene by Crestview Paint & Body.

SUPPLEMENTAL NARRATIVE**Patrol Officer BEAU A BAIER ID #: 023**

I arrived at the intersection of Brock Avenue and Crossland Street to assist Officer Mullinnix on a traffic stop involving a black in color suv. The vehicle matched the description of the black suv that was reported by Wal-Mart Asset Protection Associate, where two females had stolen items from the store. The description was given as a black suv possibly a Cadillac with a black plastic bag on the back window with a Florida tag #J111PP.

Officer Mullinnix request both parties to exit the vehicle and to stand on the side of the road while Officer Thomason drove past with the the APA from Wal-Mart. Officer Thomason advised that the APA positively identified both females as being involved in the retail theft. The driver is known to me as Tiffany Todd from previous incidents and the passenger was identified as Lana Herbert. Once they were identified they were detained in hand cuffs and I maintained watch on them as Officer Mullinnix conducted a search of the vehicle. Upon his completion of the search, I then conducted my own search. I observed two sets of flowers, multiple Hallmark cards, multiple boxes of jewelry, a men's white button dress shirt, a black t-shirt, a men's tie, Batman underwear, several plush bears, and two Dr. Peppers. Officer Thomason advised the APA had stated the men's dress shirt and the Hallmark cards had been visibly concealed and not paid for. I conducted a pat down of L. Herbert for weapons, removing a knife from her right front pocket. I then asked if I could remove items from her pockets where she stated "Yes." I then located a new white wallet in her back right pocket, sixty dollars in the back left pocket, a phone charger in the front chest jacket pocket, seven dollars in the right front pocket, two lighters in the left front pocket; along with a handful of change that I did not remove. I placed the items on the trunk of Officer Mullinnix's patrol vehicle. I then conducted a pat down with permission to remove items once located on T. Todd. I located a phone in the back right pocket and two lighters in the front left chest pocket.

Officer London arrived to conduct the searches of th two females. Officer London, upon completing the search of L. Herbert's person informed me she was done. I then collected L Herbert's hat which included her sunglasses, the change form the left front pocket, and a bag of green leafy substance. Based on the smell, my training , and my experience the bag was marijuana. L. Herbert stated: "That's old. Its been in there for a long time." I asked her what she was referring to and she nodded to the marijuana in my hand. I placed the hat and its contents on the trunk of Officer Mullinnix's patrol vehicle. Officer London then conducted a search of T. Todd. Officer Thomason then stated I needed to transport T. Todd to the jail. I then transported T. Todd to the Okaloosa County Jail.

After arriving, I helped T. Todd to exit my vehicle. As she stepped out of my patrol vehicle's rear seat, I heard something solid hit the ground and observed T. Todd step and slid her left foot as to push something under my vehicle. I escorted her inside of the jail and booked her. I then returned to my patrol vehicle, which was still in the salley port. I searched the back seat of my patrol vehicle, finding nothing. I then searched the ground under my vehicle where I discovered a clear plastic small container with two types of unknown pills. I collected the container and re-entered the jail to speak with T. Todd. As I waited for her to brought out of the cell, the nurse identified the pills were for anxiety and for an upset stomach. I asked T. Todd what the pills were, which she stated she did not know. I then told her she could be charged with entering contraband into the jail. I asked her where the contain was, which she stated she did not know. I told her that I knew it had fallen out of her pant leg when she got out of my patrol vehicle and that she attempted to push it under my vehicle. I told her she would not get it trouble this time for it because the pills were nothing other than over the counter items. She then stated they were rolled up in her pant leg, but she did not know for sure. I then told her that I did not believe her because she had been lying to me since my arrival on the traffic stop. At that time I told her to stop talking and I left the jail. As I left the in-take area, L. Herbert was in the entrance and I suggested to her if she had anything on her she needed to be up front about it now before the jail personal strip searched her. L. Herbert stated she did not have anything. I then left the jail.

This concludes my involvement in this case.
