OFFENSE/INCIDENT NARRATIVE**Patrol Officer JEFFREY W LOKEN ID #: 034****INCIDENT SUMMARY**

On 13 February 2016 at approximately 1540 hours I was dispatched to 144 First-W Ave. in reference to a burglary to a residence in progress. Dispatch advised over primary communications the suspect was a white male wearing a long-sleeve plaid shirt standing in the front yard of the residence.

Upon my arrival I observed a white male wearing a long-sleeve plaid shirt standing in the front yard of 144 First-W Ave. speaking on a cell phone. I approached the subject, later identified as Matthew Tobin, and placed him in mechanical restraints for officer safety as well as his safety. I escorted Matthew to my marked patrol car and advised him he was being detained due to a possible burglary into the residence and he matched the physical description provided by dispatch as the suspect. I placed Matthew into the back of my patrol car and made contact with K-9 officer Kriser who had located a white female, later identified as Jennifer Nolin, that was inside of the residence. Jennifer was placed into mechanical restraints and escorted to Sgt. DeRoche's patrol car.

I made contact with Jennifer and advised her of her Miranda Rights. Jennifer stated she understood her rights and wished to speak with me in regards to this incident. Jennifer stated (Post-Miranda) she was invited over to the residence by Matthew who told her he was allowed to be there. Jennifer stated Matthew had keys to the front door and did not believe he was doing anything illegal.

After speaking with Jennifer, I made contact with Matthew and advised him of his Miranda Rights. Matthew stated he understood his rights and wished to speak to me regarding the incident. Matthew stated (Post-Miranda) he was told by a "higher power" through prayer to come to the residence and rest for a couple of days. I asked Matthew who this "higher power" was and he stated "whoever you believed in". Matthew stated he was also told by the stars in the sky that the keys to the residence were in the freezer located in the rear of the open garage. Matthew stated he received permission to enter the residence by praying for it. Matthew stated he entered the residence by using the keys that he found in the freezer located in the garage. I asked Matthew about the broken window on the truck in the driveway and he stated he did break it, however, it was an accident. Matthew could not specify how he broke it when I asked him. Matthew stated he invited Jennifer over to the residence and stated to her that he was allowed to be there.

Inv. Williams arrived on scene and obtained a Buccal Swab from Matthew and Jennifer. After providing a Buccal Swab, Jennifer was released from detainment and left the scene.

I made contact with the homeowner of 144 First-W Ave., Donald Holleman, on the phone who stated he currently lives in Dothan, AL and no one should be residing in the residence. Donald stated he never allowed anyone permission to enter the residence and did not know Matthew or Jennifer. Donald stated the only person allowed on the property is Steven Brogan, who is the caretaker of the property. Donald stated the residence had been vacant for over 5 years. Donald stated the truck bearing FL Tag# 478RFR was registered to him. Donald stated he wished to pursue charges against Matthew.

After speaking with Donald on the phone, I made contact with Steven who arrived on scene to act on behalf of Donald. Steven stated he stops by the residence weekly to ensure the upkeep and maintenance of the property. Steven stated he would complete an Affidavit of Complaint on behalf of Donald.

I advised dispatch to contact Dothan PD to have an officer make contact with Donald at his residence located at 304 W Roxbury Rd., Dothan, AL 36305 in order to swear him to his statement to allow Steven to complete the Affidavit of Complaint on his behalf. Dothan Police Officer Ruiz contacted me on my department issued phone upon his arrival and placed Donald on speaker phone. Ofc. Ruiz swore Donald to his statement to allow Steven to complete the Affidavit of

Complaint on his behalf.

Steven completed a Sworn Affidavit of Complaint.

I entered the residence with Steven accompanying me and observed Matthew's FL ID, food receipts purchased with a Food stamp card addressed to Matthew, multiple business cards, letters addressed to Matthew, and 3 debit/credit cards with Matthew's name on them lying across a coffee table in the living room. I also observed multiple keys lying on the table that were identified by Steven as keys to the residence. These were photographed in place, collected, and submitted into evidence. I entered into the kitchen and observed food items in the refrigerator and pantry that matched what were on the food receipts located in the living room. Steven stated the food in the pantry and refrigerator were not present a week ago when he last inspected the residence. Photos were taken of the inside of the residence and submitted into evidence.

Upon exiting the residence, Steven pointed to a hole in the screen window on the side door located inside of the open garage and stated it had been torn open recently. I observed an arm-sized opening in the screen window that was located behind slanted-glass paneling in the door. I was able to reach my arm through the hole and unlock the dead bolt and door handle without much difficulty. Photographs of the hole and door were taken and submitted into evidence.

After completing my investigation, I transported Matthew to the Okaloosa County Jail without further incident.

I obtained video footage on my department issued body camera while I was on scene and conducting my interviews with Matthew and Jennifer.

Donald stated he would return to Crestview and inspect his residence to determine if any property was missing on 14 February 2016 and would inform the police department to file appropriate documents if necessary.

On 13 February 2016, the above named defendant did commit the offenses of Burglary to a unoccupied dwelling; Unarmed; No Assault or Battery in violation of Sec. 810.02(3B), F.S.S., and Criminal Mischief, Damage to property Under \$200.00 when he entered into the residence at 144 First-W Ave. without the permission of the homeowner, Donald Holleman. The defendant also caused damage to a window of a vehicle parked in the driveway at 144 First-W Ave causing \$100.00 worth of damage.

These offenses are evidenced by a sworn Affidavit of Complaint and sworn verbal statements provided by the complainant, Steve Brogan, who acted on behalf of the victim who is currently living in Dothan, AL, in which he stated Matthew Tobin was never given permission to enter into the residence at 144 First-W Ave. The victim, Donald Holleman, was in the presence of a Dothan Police Officer Ruiz, and verbally swore while on speaker phone to allow Steve Brogan to act on his behalf in his absence.

Physical evidence for these offenses include personal property belonging to the defendant inside of the residence to include Tax forms addressed to the defendant, his FL ID card, and multiple credit/debit cards. The victim's truck, a Red 2001 Dodge Pick up, had the right, rear window physically broken and was scattered across the bed of the truck and ground directly below the window. Photos of the window were taken and submitted into evidence.

The defendant stated Post-Miranda that he entered the home by retrieving the keys from a freezer located in the garage. When asked about how he knew where to find the keys, the defendant stated he prayed for it and was led to the freezer. The defendant stated he was instructed by a higher power to enter into the residence located at 144 First-W Ave., but could not provide a name as to who told him he was allowed to enter the residence. The defendant stated he did break the rear window on the truck, however, was unable to state how he broke it but that it was an accident. The following interview was recorded on my department issued body camera.

These offenses did occur in Okaloosa County, within the city limits of Crestview, Florida where I am a sworn Law Enforcement Officer.
